## Abstract

For decades, Intimate Partner Violence (IPV), often referred to as Domestic Violence, has been considered the purview of criminal justice; however, since the late 1990s the CDC and World Health Organization have categorized IPV as a public health crisis with significant correlates to mental and behavioral health, substance abuse, and trauma. The purpose of the Intimate Partner Violence (IPV) Workshop for Behavioral and Mental Health Professionals is to promote greater awareness and understanding of IPV, as well as its prevalence and intersectionality with behavioral and mental health; and to empower providers to assess for and respond to IPV when it presents.

Mental health, behavioral health, and substance abuse counselors are truly the front-line for many IPV victims and perpetrators. Following the workshop, participants will be able to identify indications of IPV, engage with clients in an informed, compassionate and trauma-informed way, assist with safety planning and, as needed, provide informed referrals.
